WHEREAS, the Iberia Parish Assessor has established the total assessed valuation of Real Property for 2010 at \$318,670,208; and

WHEREAS, the Iberia Parish Assessor has established the total assessed valuation of Personal Property for 2010 at \$262,485,087; and

WHEREAS, during a public hearing held on Wednesday, September 29, 2010, while acting as a Board of Review for the assessed property valuations for Iberia Parish, entities have filed appeals to the Board of Review as follows:
