SUMMARY NO. 4757 (Introduced by Regional Planning Commission)
An Ordinance DENYING a reclassification request to reclassify Van Brocklin Road from Daspit Road to Division/Gondron Road, for a depth of approximately six hundred (600) feet, from Agricultural (A-1) and Mixed Residential (R-2) to Single Family Residential (R-

SUMMARY NO. 4758 (Introduced by Regional Planning Commission)
An Ordinance amending the Iberia Parish Zoning Ordinance to approve a request for a Special Use/Conditional Use Permit to allow for a drive thru daiquiri and sandwich shop located at 7711 Weeks Island Road in District 10, all as reviewed and recommended by the Iberia Parish Regional Planning Commission.

SUMMARY NO. 351 (Introduced by Lloyd Brown, District 4)

SUMMARY NO. 4759 (Introduced by Paul G. Landry, District 7)
Discuss and consider an Ordinance proposing an amendment to Article II Section 2-01 (A) of the Iberia Parish Home Rule Charter, entitled "Composition, Qualifications and Election", to revise the current section to allow that the legislative power of the Parish Government shall be vested in a council consisting of eleven (11) members elected for four (4) year terms, with the one to be elected from and by the qualified electors of each such district commencing with the gubernatorial, local and municipal Fall 2016 elections.

SUMMARY NO. 4760 (Introduced by Parish President)
An Ordinance authorizing the issuance of [Five Million Five Hundred Thousand Dollars (\$5,500,000)] aggregate principal amount of Revenue Refunding Bonds, Series 2016, of the Parish of Iberia, State of Louisiana (the "Issuer"); prescribing the form, terms and conditions thereof and providing for the payment thereof; awarding such bonds to the purchaser thereof; providing for the redemption of certain outstanding bonds of the Issuer; and providing for other matters in connection therewith.
