ORDINANCES INTRODUCED FOR PUBLIC HEARING AND ADOPTION:

SUMMARY NO. 4762 (Introduced by Legal Counsel)

An Ordinance amending and re-enacting portions of Chapter 2 of the Compiled Ordinances regarding Council and Committee meetings to provide with respect to the times and dates of such meetings, agenda closure deadlines and agenda procedures; to provide policies and procedures for citizens to address the Council and its committees; to provide for the effective date thereof, and to otherwise provide with respect thereto.

SUMMARY NO. 4763 (Introduced by Warren P. Gachassin, Jr., District 5)

An Ordinance authorizing the levy of millages for the year 2016, as follows: (a) General Parish Millage (formerly known as the General Alimony Millage), in the rural areas of the Parish only, at the rate of 3.92 mills; (b) Exempted Municipalities Millage (formerly known as the Criminal Tax Millage), in the incorporated areas of the Parish only, at a rate of 1.71 mills; (c) Courthouse and Jail Millage, in the incorporated areas of the Parish only, at a rate of 0.76 mills; (d) Parish Library Millage, for parishwide property, at a rate of 4.00 mills; (e) Public Buildings Maintenance Millage, for parishwide property, at a rate of 4.00 mills; (f) Health Unit Millage, for parishwide property, at a rate of 1.55 mills; (g) Drainage Facilities Millage, for parishwide property, at a rate of 2.93 mills; (h) Fire Protection District No. 1 Millage, for the rural areas only, at a rate of 7.00 mills; and (i) Parish Library Millage, for parishwide property, to be used to pay outstanding debt for the Parish Library System, at a rate of 0.25 mills.
