MINUTES OF THE IBERIA PARISH MOSQUITO ABATEMENT DISTRICT COMMISSIONERS REGULAR MEETING May 20, 2025 6:00 PM AT THE DISTRICT OFFICE LOCATED 611 OLD CENTRAL TAXIWAY, NEW IBERIA, LOUISIANA 70560

Call to Order – Mr. Jay Leger, called the meeting to order at 6:00 PM.

Roll Call – Mr. Jay Leger requested the roll be taken. The following were present: Mr. Jay Leger, Dr. Christopher Dupuy, and Mr. John Simmons, Ms. Latifah Gray

Director's Report– Mr. Jones stated that April's mosquito collection numbers were small yet still active. The district is expecting a rise in collections. Both surveillance and ground operations are underway and fully operational. Aircraft and vehicular maintenance have been completed for the upcoming season.

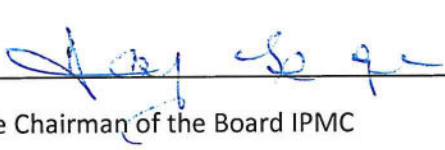
Mr. Jones stated that tax collections and expenditures are at a median with no major fluctuations. Through the first quarter of the year, collections are positive and approximately twenty-two percent over the previous year's collections same period. Proposed budgetary benchmarks are expected to be achieved. All anticipated expenditures have been captured and identified in IPG council approved FY2025 appropriations budget proposal.

Announcements — Mr. Jones shared with the board members about his recent American Mosquito Control Association Washington Day conference that convened in Washington, D.C. on last week.
