WHEREAS, an application has been filed with the Iberia Parish Regional Planning Commission for Preliminary and Final Plat approval to a subdivision of property belonging to Gordon's Disposal, LLC, located on Coteau Road in District 14, to subdivide 46.612 acres of property into One Hundred Ninety-One (191) Lots for residential use, subject to compliance with Planning Commission Staff Report PC2024-0012, all as reviewed and recommended by the Iberia Parish Regional Planning Commission; and

WHEREAS, the Iberia Parish Regional Planning Commission conducted a Public Hearing on August 19, 2024 and recommended Preliminary and Final Plat Approval to a subdivision of property belonging to Gordon's Disposal, LLC, located on Coteau Road, District 14, to subdivide 46.612 acres of property into One Hundred Ninety-One (191) lots for Residential use, subject to compliance with Planning Commission Staff Report PC2024-0012.

NOW, THEREFORE, BE IT RESOLVED, that the Iberia Parish Council does hereby grant Preliminary and Final Plat Approval to a subdivision of property belonging to Gordon's Disposal, LLC, located on Coteau Road, District 14, to subdivide 46.612 acres of property into One Hundred Ninety-One (191) lots for Residential use, subject to compliance with Planning Commission Staff Report PC2024-0012, all as reviewed and recommended by the Iberia Parish Regional Planning Commission.

BE IT FURTHER RESOLVED, that said Preliminary and Final Plat approval is conditional upon the following items from the Staff Report PC2024-0012:

STAFF RECOMMENDATION:

Approval is recommended subject to the following conditions and all standards of the Iberia Parish Subdivision Regulations.

CONDITIONS:

- 1. Submittal of complete construction plans to the Department of Public Works. Construction plans shall include, but not be limited to, a site grading, drainage and erosion control plans and details of all tie-ins to public infrastructure. The Final Plat may not be recorded nor building permits issued until the construction plans have been approved and constructed. (Public Works Engineering)
- 2. The construction plans shall include geotechnical recommendations for all roadway typical sections, including sub-base material, within the development. The recommendations

shall be based on site specific soil borings, properties of any borrow material, and anticipated traffic loading(s). The Final Plat may not be recorded nor building permits issued until the construction plans have been approved and constructed. (Public Works Engineering)

The construction testing/inspection results are to be submitted to Public Works at the time of final inspection. The Final Plat may not be recorded nor building permits issued until the construction plans have been approved and constructed. (Public Works Engineering)

- 4. New public streets shall be constructed in accordance with the Iberia Parish Subdivision Regulation. (Public Works Engineering)
- 5. Submittal of a drainage impact analysis to the Department of Public Works for review and approval is required. Drainage impact analysis shall include, but not be limited to, a drainage area map for existing and proposed conditions, methodology, computations, lot grading plan, and summary, and if applicable, the capacity of roadside ditches and pipe sizing chart. Please note, a drainage impact analysis shall be submitted in the format noted in the Iberia Parish Subdivision Regulations. Building permits shall not be issued until the analysis has been approved. Please note, all residential and commercial development that results in a post development runoff that exceeds the development areas pre-development runoff rate shall be required to mitigate the increase through drainage improvements. The development drainage design shall be based on a five (5) year storm event for residential developments and a ten (10) year storm event for commercial developments. (Public Works Engineering)
- 6. Upon reviewing the drainage impact analysis, private and/or public drainage servitudes may be required to achieve proper storm water management. (Public works Engineering)
- 7. No construction of any development components which are the subject of any Preliminary or Final Plat approval by the Planning Commission/Parish Council shall be commenced until a favorable written approval of the drainage impact analysis has been made by the Public Works Director (or his/her designee). Violation of this provision can result in a cease and desist order being issued for the development (Public Works Engineering)
- 8. The Developer will need to install the water system in the subdivision and donate the water system to WWD#3 for operation and maintenance. The Developer's Engineer will need to submit plans and specifications for approval. See attached requirements. (Water Works District # 3)
