The Parish Council of the Parish of Iberia, State of Louisiana, was duly convened as the Governing Authority of the Parish of Iberia by Mr. James P. Trahan, its Vice Chairman, who announced that the Council was now ready to conduct its business.

## COUNCIL MEMBER ANNOUNCEMENTS

- 1. Councilman Marcus "Bruce" Broussard announced that Iberia Parish Parks and Recreation will be sponsoring America's Youth Co-Ed Flag Football for the 2024 Fall Season for Pre-K to 8th Grade. The season will run from September 17, 2024 to November 5, 2024 with all games to be held at Weeks Park Road, New Iberia, LA. The registration fee is \$145 and covers 7 weeks of action plus an end-of-season tournament. The deadline for registration is July 31, 2024. - Vice Chairman James P. Trahan announced that the next Iberia Parish Council Meeting will be held on Wednesday, July 24, 2024 at 6:00 p.m.

## PARISH PRESIDENT ANNOUNCEMENTS

- 1. Parish President M. Larry Richard announced that Litter Abatement cleanup was conducted on Saturday, June 22, 2024 with 12 individuals participating. They picked up 143 bags of trash, televisions, tin, tires and plastic chairs in the areas of Nelson Canal Road, Blanchard Road and Darnall Road.
- 2. President Richard informed the Council that the Public Works Department completed several tasks including culvert inspections and cleaning, debris removal and cleanup of illegal dumping, road side drainage, road patching and repairs, side booming, tree trimming and hauling limestone.
- 3. President Richard gave a project update on Vida Shaw Bridge which is expected to be completed by Southern Contractors, LLC in late November, 2024.
- in late November, 2024.

  4. President Richard wished Councilman Brian P. Napier a Happy Birthday and thanked him for his service to Iberia Parish.
- 5. President Richard acknowledged that Lee Turner with Senator Bill Cassidy's Office was present in the audience.
- 6. President Richard reminded the Council that Iberia Parish received \$2 Million Dollars in Federal funds for the Hangar Construction located at Acadiana Regional Airport and that U.S. Senator Bill Cassidy was essential in Iberia Parish receiving those funds.
- 7. President Richard announced that U.S. Senator Bill Cassidy will be visiting Acadiana Regional Airport on Thursday, July 18, 2024, between 9:00 a.m. and 10:00 a.m. to announce to the media that Iberia Parish received a \$2 Million Dollar Delta Regional Authority Grant for East Side Development/AvEx Expansion Hangar Project.
- 8. President Richard reminded everyone that a permit is required for all roof replacements and repairs and can be obtained through Iberia Parish Permit, Planning and Zoning Department. He further advised that a licensed insured contractor is required for all roof installations and this will ensure that roofs are being installed correctly to withstand hurricane force winds and storms.
- 9. President Richard also reminded everyone to visit the website for Iberia Parish Government which can be viewed at www.iberiaparishgovernment.com.

## PUBLIC COMMENTS (Policy allows Three (3) Minutes/person)

- 1. Comments from the General Public on Agenda Items:
  - a. Ms. Carol Fishburn addressed the Council regarding Summary No. 127 and requested that the moratorium be extended for another year and stated that she is in opposition to a solar farm development in Iberia Parish.
  - b. Ms. Brenda Smith addressed the Council regarding Summary No. 127 and requested that the moratorium be extended for as long as possible and stated that she is also in opposition to a solar farm being built in Iberia Parish.
  - c. Mr. Richard Phillips addressed the Council regarding Summary No. 127 and his experience in issuance of Building Permits and property rights of the people.
     d. Ms. Kim Spiker addressed the Council regarding Summary
  - d. Ms. Kim Spiker addressed the Council regarding Summary No. 127 and requested that the moratorium be extended for at least one year until an ordinance can be written. She stated that the property where the solar farm would be built is zoned for agriculture and would need to be rezoned to industrial and that solar farms should only be allowed in an industrial zoned area.
  - e. Ms. Catherine DeGroat addressed the Council regarding Summary No. 127 and read an article entitled "Destroying Green to Go Green" in opposition to a solar farm being built in Iberia Parish. Ms. DeGroat invited the Council to a Tour of Yards which can be set up for Councilmen to visit their homes.
  - f. Ms. Krista Bernard, member of the Chitimacha Tribe of Louisiana, addressed the Council regarding Summary No. 127 and spoke of the Acadian heritage that would be lost if a solar farm would be built. She stated that rivercane is grown in this area which the Chitimacha Tribe uses to weave basketry, there may be unknown grave sites in this area and Native American aspects and culture that would be lost. Ms. Bernard requested that an comprehensive archeological survey be done by a Louisiana based company that knows local history before a solar farm is built.
  - g. Mr. David DeGroat addressed the Council regarding Summary No. 127 and read a letter he sent to Iberia Parish Council relating to dangers and health risks associated with solar farms. He further requested that the moratorium be extended.

- h. Mr. Brent Richard addressed the Council in support of an extension of the moratorium regarding Summary No. 127 and stated that this would allow additional time to write an Ordinance.
- I. Mayor Pro Tempore' Ricky Gonsolin for the City of New Iberia and former Iberia Parish Councilman, serving for eight years addressed the Council in support of an extension of the moratorium in Summary No. 127.
- j. Mr. Steve Thibodeaux agrees with the extension of the moratorium in support of Summary No. 127.
- k. Ms. Virginia Segura also agrees with the extension of the moratorium in support of Summary No. 127.
- 1. Ms. Donna Moral addressed the Council in support of an extension of the moratorium regarding Summary No. 127 and stated her opposition to a solar farm being built in Iberia Parish.
- m. Mr. Todd Segura also addressed the Council in support of an extension of the moratorium regarding Summary No. 127 and requested that Iberia Parish be first in not accepting a solar farm.
- n. Ms. Linell Champagne, Real Estate Agent, McGee Scott Realty addressed the Council regarding Summary No. 127 and stated that a solar farm would decrease the values of homes and property if built in Iberia Parish.
- o. Ms. Rebecca McGee, Broker and Co-Owner of McGee Scott Realty informed the Council that a solar farm would decrease property values in Iberia Parish and requested that it not be allowed in the Parish. Ms. McGee also requested an extension of the moratorium relative to Summary No. 127.
- Ms. Susan McFarland stated that she is present in support of the people of Iberia Parish requesting an extension of the moratorium regarding Summary No. 127.
- q. Mr. Joshua Trosclair, member of the Houma Nation and member of La. Against False Solutions Coalition, stated that he can provide data to the Council regarding the environmental affects of solar farms regarding Summary No. 127 and requested an extension of the moratorium. Mr. Trosclair also agrees that an archeological survey should be done prior to a solar farm being built in Iberia Parish.
- r. Mr. Mark Reese, Archaeologist/Anthropologist with University of Louisiana at Lafayette, nonresident of Iberia Parish addressed the Council regarding Summary No. 127. He stated that a few years ago they starting looking for homesites and gravesites of the Acadian in the area known as Cul de Sac Fausse Pointe. He further stated that this area is a historic landscape with potential burial sites of Chitimacha ancestors going back at least 2,000 years and plantations. Mr. Reese agreed that a full comprehensive archeological survey of the entire area should be done prior to a development of a solar farm in Iberia Parish.

A RESOLUTION AMENDING RESOLUTION NO. 2024-23, AND EXTENDING THE TEMPORARY MORATORIUM ON THE DEVELOPMENT, ESTABLISHMENT, AND/OR CONSTRUCTION OF SOLAR FARMS IN THE UNINCORPORATED AREAS OF IBERIA PARISH FOR AN ADDITIONAL PERIOD OF ONE YEAR, SPECIFICALLY, UNTIL AUGUST 26, 2025.

WHEREAS, the Iberia Parish Council hereby amend Resolution No. 2024-23, extending the temporary moratorium on the development, establishment, and/or construction of Solar Farms in the unincorporated areas of Iberia Parish for an additional period of one year, specifically, until August 26, 2025; and

WHEREAS, the development, establishment and/or construction of Solar Farms in unincorporated areas of Iberia Parish create unique planning and zoning issues; and

WHEREAS, each of the issues set forth relate to the health, safety, and welfare of the citizens in unincorporated areas of Iberia Parish; and

WHEREAS, the Iberia Parish Council has been reviewing the Code of Ordinances of the Parish of Iberia with respect to Solar Farms and changes that may be necessary to protect public health, safety, and general welfare; and

WHEREAS, the temporary moratorium previously adopted by Resolution No. 2024-23, on the development, establishment, and/or construction of Solar Farms in unincorporated areas of Iberia Parish shall be extended for an additional period of one (1) year which will allow the Iberia Parish Council time to prepare, consider, and adopt a comprehensive Ordinance to ensure that any such development or government are governed by rules and regulations that take into consideration the unique planning and zoning issues of such developments and adequately addresses the health, safety, and welfare concerns of the citizens of Iberia Parish.

A RESOLUTION AMENDING 2024 GENERAL FUND BUDGET IN THE AMOUNT OF \$151,317 TO APPROPRIATE ADDITIONAL EXPENDITURES FOR THE PERMIT DEPARTMENT AS FOLLOWS: (1) \$38,586 PARTIAL YEAR SALARIES AND BENEFITS FOR AN ADDITIONAL BUILDING INSPECTOR; (2) \$44,805 PARTIAL YEAR SUBSCRIPTION EXPENDITURE FOR SOFTWARE CONTRACT (\$52,397 CONTRACT AMOUNT LESS AMOUNT PREVIOUSLY BUDGETED) (CONTRACTUAL EXPENDITURE INCLUDES \$38,625 OF IMPLEMENTATION FIRST YEAR EXPENDITURE ONLY); (3) \$10,000 VEHICLE REPAIRS/MAINTENANCE; (4) \$800 VEHICLE INSURANCE AND \$9,776 GENERAL LIABILITY INSURANCE; (5) \$10,000 TRAVEL AND TRAINING FOR CONTINUING EDUCATION COURSES FOR INSPECTORS; (6) \$350 FOR UNIFORMS FOR INSPECTORS; AND (7)\$37,000 FOR DEPARTMENT TRUCK PURCHASES, ALL TO BE FUNDED FROM BUILDING PERMIT REVENUES.
