The Parish Council of the Parish of Iberia, State of Louisiana, was duly convened as the Governing Authority of the Parish of Iberia by Mr. Warren P. Gachassin, Jr., its Chairman, who announced that the Council was now ready to conduct its business.

COUNCIL MEMBER ANNOUNCEMENTS

1. Councilman Natalie Broussard announced that Volunteer Louisiana and Community Emergency Response Team (CERT) will be hosting the Parish Prepared - A Citizen's Disaster Conference for Family and Community Preparedness Event on Thursday, June 13, 2024 at 5:30 p.m. at the New Iberia's Sliman Theatre, 129 E. Main Street, New Iberia, Louisiana, to educate and prepare the community for emergencies. There will be a number of experts including Prescott Marshall with Iberia Parish 911 Communications District, Beauregard Parish Sheriff Mark Herford and Meteorologist Dave Baker speaking at the event.
2. Chairman Warren P. Gachassin, Jr. announced that the next Iberia Parish Council Meeting will be held on Wednesday, June 26, 2024 at 6:00 p.m.

PARISH PRESIDENT ANNOUNCEMENTS

1. Parish President M. Larry Richard announced that on Saturday, June 1, 2024 the Iberia Parish Litter Abatement Committee picked up 55 bags of trash, wood, tires and debris in the areas of Monnot Street, Saint Peter Street and Pellerin Street.
2. President Richard informed the Council that during the period of May 22, 2024 through June 11, 2024, the Public Works Department completed several tasks including culvert inspections and repairs, removal of trees due to various storms, debris pickup, drainage in field and roadsides, grating roads, hauling limestone, cleanup of illegal dumping, road crossing repair and patching, and sidebooming of fields and front ditches.
3. President Richard gave a project update of the fiber optic installation that will be provided to approximately 400 homes and businesses which includes 24 miles (125,000 feet) of fiber optics along the proposed areas of Highway 90 from Highway 88 to South Lewis Street, Avery Island Road and Northern Port of Iberia, as well as Corporate Drive and Grand Prairie Road. The total project expenses are \$1,262,000, for which Cajun Broadband will contribute 10% of construction costs in the amount of \$100,000 and pay an additional \$172,500 in installation costs. Iberia Parish Government will contribute 79% of the project amount from ARPA funds.
4. President Richard announced that the Iberia Parish Key Leaders 2024 Hurricane Season Meeting will be held on Wednesday, June 26, 2024 at 10:00 a.m. at the Sliman Theatre, 129 E. Main Street, New Iberia, Louisiana. Community leaders will focus on lessons learned in prior hurricanes and responses with other parishes which will serve as a platform for various agencies and organizations.
5. President Richard proclaimed the week of June 24-30, 2024 as "Peliz Mosquito Week." The Mosquito Control Proclamation was read by CAO Milton "Bo" Belanger, III.
6. President Richard recognized Director of Mosquito Control Herff Jones for his hard work and dedication in controlling the mosquito population.
7. President Richard also reminded everyone to visit the new website for Iberia Parish Government which can be viewed at www.iberiaparishgovernment.com.
