A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BY AND BETWEEN IBERIA PARISH GOVERNMENT AND GARON PAUL ATKINSON LEWIS FOUNDATION (NEW IBERIA TEEN COURT PROGRAM) TO PROVIDE FUNDING IN THE TOTAL AMOUNT OF \$10,000 IN SUPPORT OF SAID PROGRAM.

AN ORDINANCE APPROVING THE RECLASSIFICATION REQUEST FOR THE PROPERTY OF VERRET LAND, LLC, LOCATED AT THE CORNER OF LOREAUVILLE ROAD (LA. 86) AND EMILE VERRET ROAD (LA. 3195), WITH SAID PARCEL BEING ZONED FROM R-2 (MIXED RESIDENTIAL) TO C-2 (GENERAL BUSINESS), LOCATED IN DISTRICT 8, SUBJECT TO COMPLIANCE WITH ZONING COMMISSION STAFF REPORT ZC2023-0001, ALL AS REVIEWED AND RECOMMENDED BY THE IBERIA PARISH REGIONAL PLANNING COMMISSION.

SECTION 1. That Ordinance No. 2009-02-4099, adopted February 25, 2009, established the Zoning Regulations for rural Iberia Parish and is recorded in the Official Records of Iberia Parish at COB 1430, Page 65.

SECTION 2. That the Iberia Parish Zoning Commission conducted a Public Hearing on February 9, 2023 and recommended the reclassification request of the property of Verret Land, LLC, located at the corner of Loreauville Road (La. 86) and Emile Verret Road (La. 3195), with said parcel being zoned from R-2 (Mixed Residential) to C-2 (General Business), located in District 8, subject to compliance with Zoning Commission Staff Report ZC2023-0001.

SECTION 3. ### CONDITIONS OF DEVELOPMENT:

- (1) Adequate provisions shall be made such that development activities do not adversely affect the adjacent properties. All building permits and construction activities must be completed such that the adjacent properties are not impacted from alteration of the historical drainage patterns. (Public Works).
- (2) All work to be performed within public Right-of-Way or Easement must be permitted. (Public Works)
