REPORTS (PARISH OR OTHER GOVERNMENTAL AGENCIES):

1. Ms. Sara Fawcett-Gary, Transportation Director of the Acadiana Planning Commission, provided an update on the South Lewis Street Widening Project. Ms. Fawcett-Gary informed the Iberia Parish Council that a meeting was held in October where percentages of the project were discussed with the contractor of the design firm, Meyer Engineers, Ltd. She explained that once the supplemental contract is signed by President M. Larry Richard, they will design the first set of plans, including preliminary plans, final plans, rights of way process, and then construction. Once the agreement is signed, a Notice to Proceed will be issued to Meyer to begin the design. This design phase takes about a year to complete and other work will be done, such as boring to determine the integrity of the base, surveying for rights of way maps, and data collection of the traffic pattern.

Upon questioning, Ms. Fawcett-Gary stated that the cost estimate for rights of way for La. 675 was \$64,0000 and it came in at \$580,000.

Ms. Fawcett-Gary pointed out that the estimated cost for rights of way for Lewis Street is \$50,000, which cost could increase depending on where the rights of way will be taken.

Upon questioning, Ms. Fawcett-Gary stated that cost estimate for the La. 675 Roundabout Project is \$2,750,00. She pointed out that there is "leftover" Capital Outlay money from the ARA Access Road Project and Administration is working with the State to use for the Roundabout Project.

Upon questioning, Ms. Fawcett-Gary stated that the estimated cost for the Lewis Street Widening Project is \$2,190,000 and \$60,000 for utility relocation. She pointed out any funds not utilized for the utility relocation can be into construction. She stated that the design has already been authorized and estimated costs total \$2,300,000, which includes rights of way, utilities, and construction and the Parish would provide 20% matching funds.

PUBLIC WORKS REPORTS:

1. The Public Works Department Report for Closed Work Orders dated April 26 - May 9, 2023 was emailed to the Council members.

COUNCIL MEMBER ANNOUNCEMENTS

- 1. Councilman Scott Saunier stated that this week is National EMS Week. He requested that if you see EMTs, Paramedics, or firefighters, please thank them for their service.
- 2. Councilman Eugene A. Olivier, Sr. stated that he continues to monitor the Bills that are going through Baton Rouge along with the Police Jury Association to make sure that there is no negative impact on local government.
- 3. Councilman Eugene A. Olivier, Sr. also stated that he had the opportunity to attend the Rural Community Funding Summit sponsored by United States Senator Bill Cassidy. He met with GOSEPH, Louisiana Department of Environmental Qualities, Louisiana Office of Community Development, United States Rural Development, United States Economic Development Administration, as well as many other departments.
- 4. Councilwoman Lady Fontenette Brown stated that Delta Biofuel is making a significant investment of \$100,000,0000 in a new renewable fuel facility in Iberia Parish, Louisiana, specifically in District 12. This ground-breaking facility is expected to create 126 new direct jobs with an average salary of \$62,500 and 149 indirect jobs, for a total of 275 new jobs. It will provide a new market for sugarcane farmers as bagasse is a byproduct of sugarcane processing. She stated that this project is a testament to President Richard and the Iberia Parish Council's commitment to economic growth and thanked all those who supported this project.
- 5. Councilman Natalie Broussard stated that she attended the Parish's Hurricane Preparedness Meeting held by the Parish. She stated that CERT has been working with Volunteer Louisiana to present Parish Prepared to be held at Westgate High School Auditorium on June 8, 2023 at 5:30 p.m. This is a conference to prepare yourself, family, and friends and help individuals get prepared in the case of a disaster. There will be information in regards to the Highway 90 Construction and

- Hurricane Evacuations. There will door prizes, emergency starter kits will be available at the event, and is a free event.
- 6. Councilman Natalie Broussard announced that there will be a Senior Resource Fair on June 10, 2023 from 8:00 a.m. 1:00 p.m. at the Cyr Gates Community Center sponsored by Maison Teche, Iberia Medical Center, and Iberia Parish Council on Aging.

- 1. Chief Administrative Officer Milton Belanger, III announced that construction began on Labit Road on May 22, 2023 and is scheduled to be completed within the month.
- 2. CAO Belanger announced that the bidding process for the Labit Road Bridge will be in June, with construction to begin in August, and completion scheduled in January 2024.
- 3. CAO Belanger announced that Bid Opening for the Jefferson Canal South Project will be held on Thursday, June 15, 2023 at 10:00 a.m.

President Richard thanked the Director of Homeland Security Prescott Marshall for hosting and coordinating the meeting and further thanked the Iberia Parish Government Departments for their attendance at the meeting. We are currently working with the Iberia Parish Sheriff's Office, Louisiana Department of Transportation and Development, City of New Iberia Police Department, and State Police to discuss the route to be used for hurricane evacuations due to the U. S. 90 lane closures

Larry Richard, Parish President of Iberia Parish Government, recognizing the month of May 2023 as Building Safety Month.
