1. Mr. Troy Guidry with Acadian Companies gave a brief presentation to the Council about opportunities for employment which included training for their positions. Mr. Adam Olivier, Operations Manager with Acadian Ambulance, mentioned that Acadian has been in business for 51 years. Acadian Ambulance is dedicated to operating their own Mobile Command Center and are offering in house training for the community.

COUNCIL MEMBER ANNOUNCEMENTS

1. Council member Natalie Broussard announced that CERT and Volunteer Louisiana hosted Parish Prepared at Westgate High School with over one hundred participants. This event was a citizens disaster conference for family and community preparedness.

PARISH PRESIDENT ANNOUNCEMENTS

- 1. Chief Administrative Officer Milton Belanger, III, gave an update on Waterworks District No. 3, which included that an air compressor upgrade was purchased, a master control panel upgrade was purchased, and the replacement of a raw water line, which replaced 200 feet of line.
- 2. CAO Belanger announced that the Iberia Parish Litter Abatement Committee picked up 98 bags of trash, tires, and debris on Jefferson Island Road.
- 3. CAO Belanger announced that Parish President M. Larry Richard estimated the demolition date for the Jeanerette home on Louise Street will be next week.
- 4. CAO Belanger introduced Mr. Ben Langlinais, Drainage Assistant to Parish Government, who then made a presentation on the results of a St. Mary/Iberia Study, which evaluated the general drainage potential and its association with Sea Level Rise (SLR)/Subsidence, the Jaws Terracing Project, any silting of Jaws Bay waterways, and increased flow from the Wax Lake Outlet (WLO) and Lower Atchafalaya River (LAR). In conclusion, Mr. Langlinais stated that this study was driven by water not draining from fields; however, all of the models indicated that it was only a 2/10 of a foot difference in the surface and did not recommend dredging any areas. He stated that Iberia Parish does not have control over two items, specifically, the tide and outlets in other Parish's control.

ORDINANCE NO. 2023-06-5149

AN ORDINANCE TO AMEND CHAPTER 1 OF THE COMPILED ORDINANCES OF IBERIA PARISH, LOUISIANA TO INCLUDE "PRECINCTS DESIGNATED" IN ACCORDANCE WITH THE MERGING OF CERTAIN QUALIFYING PRECINCTS.

THAT THE IBERIA PARISH COUNCIL DOES HEREBY ORDAIN:

- SECTION 1. The Iberia Parish Government determined that under the 2020 Census, the current single-member election districts for the members of the Iberia Parish Government were malapportioned and thereafter adopted Plan 2 as their new election plan.
- SECTION 2: All Parish-level redistricting and State-level redistricting has been completed.
- SECTION 3: As of December 31, 2022, the precinct freeze window has opened that now allows for certain precincts to qualify for merging into an adjoining precinct to reduce the total number of precincts and election expenditures.
- SECTION 4: That the Iberia Parish Council, in Regular Session assembled, does hereby amend the following qualifying precincts in their descriptions and the precinct boundaries are modified by the precinct mergers and are hereby described to wit in the attached Exhibit A.¹
- SECTION 5. On February 9, 2022 the Iberia Parish Council adopted Ordinance No. 2022-02-5179 which set the precinct boundaries under their adopted Plan 2.
- SECTION 6. The Parish Council wishes to merge certain qualifying precincts into an adjacent precinct as authorized under LRS 532.1, et, al., and
 - Exhibit A provides for the written description of the merged precincts, and;
 - b. Exhibit A also establishes the polling locations for each of the merged precincts.
- SECTION 7. That Ordinance No. 2022-02-5179, is hereby amended to reflect and describe the precincts as merged and hereby sets the polling locations for each precinct in accordance with Exhibit A as attached.
- SECTION 8. That this Ordinance shall become effective immediately upon adoption by the Iberia Parish Council and approval by the Parish President in accordance with Section 2-13 of the Iberia Parish Home Rule Charter.
