WHEREAS, it is the goal of the Applicant that minority business enterprise be utilized to the fullest extent possible in connection with this project, and that definitive procedures shall be established and administered to ensure that minority businesses shall have the maximum feasible opportunity to compete for contracts when procuring construction contracts, supplies, equipment, or consultant and other services:

- 1. - 4. That the <u>Parish President</u> is authorized to set and execute affirmative minority business policies in connection with the project's procurement needs.
- 5. That the <u>Parish President</u> is authorized to execute grant contract agreements on behalf of <u>Iberia Parish Government</u> with the Louisiana Department of Transportation and Development for aid in the financing of the operating or capital assistance projects.
- 6. This resolution is applicable for a period of one year unless revoked by the governing body and copy of such revocation shall be furnished to the DOTD.
