### PARISH PRESIDENT ANNOUNCEMENTS

- 1. Chief Administrative Officer Milton Belanger, III, also thanked everyone involved in the cleanup of Railroad Road.
- 2. CAO Belanger announced that due to the drought and increased water consumption, Waterworks District No. 3 had to shut water off for a couple of nights to rebuild water levels. This also enabled contractors to install a new 12" waterline inside the plant to help increase water flow. He thanked the customers of Waterworks District No. 3 for their patience at this time.
- 3. CAO Belanger announced that the Iberia Parish Litter Abatement Program picked up 101 bags of trash on July 29, 2023 in the areas of Right Way Road, Saint Peter Street, East Admiral Doyle Drive to Canal Street in Jeanerette, Pellerin Street and Monnot Street.
- 4. CAO Belanger requested that Iberia Parish Homeland Security E-911 Communications Director Prescott Marshall give updates on Iberia Parish emergency evacuation routes and Parc Perdue. Iberia Parish Homeland Security E-911 Communications Director Prescott Marshall informed Iberia Parish Council of the unprecedented problems that could occur during a hurricane evacuation due to the ongoing construction on Highway 90. Mr. Marshall stated that the Parc Perdue Grant Project is taking longer than expected. He explained that during Phase I, the engineering work has to be completed. There are approximately \$300,000 in funds appropriated for this project. He explained that engineering will establish the exact location where the pond will be located. The Parc Perdue Project will be completed in approximately two years.

WHEREAS, certain types of merchandise can be imported into a Zone without paying import duties and customs duties and excise taxes are due when the merchandise is transferred from the FTZ for U. S. consumption; and

WHEREAS, merchandise in a zone may be assembled, exhibited, cleaned, manipulated, manufactured, mixed, processed, relabeled, repackaged, repaired, salvaged, sampled, stored, tested, displayed and destroyed; and

WHEREAS, the Port of South Louisiana serves as grantee of Foreign Trade Zone 124 and consists of companies such as Valero Refinery, Marathon Oil, Shell Oil Products U.S., Louisiana Offshore Oil Port, Bollinger Shipyards, North American Shipbuilders, M-I, LLC, Baker Hughes, Excalibar Minerals, Halliburton Energy Services, Danos & Curole Marine Contractors, and Conrad Shipyard; and

WHEREAS, these companies are all able to compete on a level playing field with companies around the world due to the duty savings realized through the FTZ program, which in turn, helps the local economies in terms of jobs, creating new ones, and retaining the jobs already in place, attracting new businesses, as well as supporting the local vendors with supplies and services; and

WHEREAS, that Global Risers, LLC, whose offices are located at 1401 Constitution Avenue, NW, Room 21013, Washington, DC 20230, provides offshore drilling services to unlock oil and gas resources for their customers and delivers energy around the world.

WHEREAS, that Global Risers, LLC consistently utilizes the services of local third party services; and

WHEREAS, Global Risers, LLC is requesting support for their application to the Foreign Trade Zone Board for a subzone site within Foreign Trade Zone 124; and

WHEREAS, it is the understanding that if the request is granted, imported inventory and inventory held for export in Foreign Trade Zone Subzone will be exempt from the ad valorem tax.

WHEREAS, the Port of South Louisiana serves as grantee of Foreign Trade Zone 124 and consists of companies such as Valero Refinery, Marathon Oil, Shell Oil Products U.S., Louisiana Offshore Oil Port, Bollinger Shipyards, North American Shipbuilders, M-I, LLC, Baker Hughes, Excalibar Minerals, Halliburton Energy Services, Danos & Curole Marine Contractors, and Conrad Shipyard; and

WHEREAS, these companies are all able to compete on a level playing field with companies around the world due to the duty savings realized through the FTZ program, which in turn, helps the local economies in terms of jobs, creating new ones, and retaining the jobs already in place, as well as supporting the local vendors with supplies and services; and

WHEREAS, that Cimbar Resources, Inc., has acquired Excalibar Minerals, LLC and would like to assume the FTZ designation (FTZ#124N) and pursue activation by U.S. Customs and Border Protection; and
