It was discussed to possibly create a retention pond to properly assist in draining the ditch along Admiral Doyle Drive. Chairman Norris also gave an update on First Solar, Inc.
2. Iberia Medical Center Chief Executive Officer Dionne Viator gave an overview of the budget for Iberia Medical Center regarding Resolution Summary No. 203 and hospital renovations taking place as a result of the tornado that occurred in 2023. CEO Viator also gave an update on new services being offer to the community. The Louisiana Hospital Association issued one of three Safety Star Awards to Iberia Medical Center recognizing doctors, nurses and employees for their high quality care.

2. Councilman Scott Saunier announced that today he attended a 20 year celebration for a partnership between South Louisiana Community College and National EMS Academy. It is one of the largest facilities offering emergency medical training.

PARISH PRESIDENT ANNOUNCEMENTS

1. Parish President M. Larry Richard reminded the Council and citizens of Iberia Parish to participate in the Storm Water Survey. You will go to: [www.iberiagov.net](http://www.iberiagov.net) to complete the survey under the Government section of the website.
2. President Richard announced that the State of the Parish will be held on Monday, November 13, 2023 from 6:00 p.m.-7:00 p.m. at the Sliman Theatre.
3. President Richard gave an update regarding the Hangar Drive and 3212 Roundabout Capital Outlay request. President Richard stated that he testified before the Legislative Joint Committee. Through his testimony, Iberia Parish was able to get \$16 million from the state, with \$4 million to start the project, then will be received in \$4 million dollar increments, without the necessity of having to these match funds. This project will require the abandonment a portion of Tower Drive.
4. President Richard announced that First Solar, Inc. will have approximately 100 trucks coming to Iberia Parish and we will need access not only on the First Solar, Inc. property but to access the Airport property as well for this project.
5. President Richard stated that Iberia Parish received a bid of \$960,000 for the development of waterlines. First Solar, Inc. gave \$800,000 to Iberia Parish to begin the work. President Richard announced that he will be requesting additional funds from Economic Development District No. 1 for the completion of the waterlines.
6. President Richard gave an update on Labit Road Bridge and Vida Shaw Bridge, the revised estimate exceeds the budgeted amount

by \$83,398 for the Vida Shaw Bridge, and \$107,500 for the Labit Road Bridge.

7. President Richard announced that bids are being accepted for sale of Coteau Library Building located in Francis Romero Memorial Park on Wednesday, November 8, 2023 at 2:00 p.m. in Chambers, 4th Floor, Courthouse.
8. President Richard announced that Iberia Parish held Household Waste Day on October 21, 2023. A RESOLUTION CERTIFYING TO THE LA. DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT THAT THE PARISH HAS MET ALL THE PREREQUISITES TO PARTICIPATE IN THE OFF SYSTEM BRIDGE REPLACEMENT PROGRAM FOR THE PERIOD OF OCTOBER 1, 2022 THROUGH SEPTEMBER 30, 2023.

WHEREAS, the Code of Federal Regulations as enacted by the United States Congress mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity, and posted in accordance with the National Bridge Inspection Standards and that an inventory of these bridges be maintained by each State; and

WHEREAS, the responsibility to inspect, rate, and load post those bridges under the authority of Iberia Parish in accordance with those standards is delegated by the La. Department of Transportation and Development to Iberia Parish.

THEREFORE, BE IT RESOLVED, by the governing authority of Iberia Parish (herein referred to as the Parish) that the Parish in regular meeting assembled, does hereby certify to the La. Department of Transportation and Development (herein referred to as the DOTD), upon recommendation by a licensed engineer, that for the period of October 1, 2022 through September 30, 2023:

1. The Parish has performed all interim inspections on all Parish owned or maintained bridges in accordance with the National Bridge Inspection Standards.
2. All bridges owned or maintained by the Parish have been structurally analyzed and rated by the Parish as to the safe load capacity in accordance with the AASHTO Manual for Maintenance Inspection of Bridges. The load posting information that has been determined by the La. DOTD for all bridges where the maximum load under Louisiana State Law exceeds the load permitted under the operating rating as determined above has been critically reviewed by the Parish. Load posting information has been updated by the Parish to reflect all structural changes, any obsolete structural ratings or any missing structural ratings.
3. All Parish owned or maintained bridges which require load posting or closing are load posted or closed in accordance with the table in DOTD Engineering Directives and Standards Manual Directive No. 1.1.1.8. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting.
4. All bridges owned or maintained by the Parish are shown on the attached listing in the format specified by the La. DOTD. Corrections to data supplied to the Parish by the La. DOTD are noted.

These stipulations are prerequisites to participation by the Parish in the Off System Bridge Replacement Program.

AN ORDINANCE AMENDING CHAPTER 20 OF THE COMPILED ORDINANCES OF THE PARISH OF IBERIA, LOUISIANA TO ESTABLISH FOUR-WAY STOP SIGNS AT THE INTERSECTIONS OF (A) AVENUE BELLE TERRE AND BONNET STREET, AND (B) AVENUE BELLE TERRE AND TIMBERSTONE DRIVE, LOCATED IN TIMBERSTONE ESTATES, DISTRICT 6.

THAT THE IBERIA PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That Chapter 20, Section 20-108 Three- or four-way stop intersections of the Compiled Ordinances is hereby amended to include four-way stop signs at



the intersections of (a) Avenue Belle Terre and Bonnet Street, and (b) Avenue Belle Terre and Timberstone Drive, located in Timberstone Estates, District 6, as follows:

(30) Four-way stop signs at the intersections of (a) Avenue Belle Terre and Bonnet Street, and (b) Avenue Belle Terre and Timberstone Drive, located in District 6.

SECTION 2. That the Public Works Department is hereby authorized to install all signage to effect this Ordinance.
