REPORTS (PARISH OR OTHER GOVERNMENTAL AGENCIES):

1. Mr. Paul Allain addressed the Iberia Parish Council regarding the Evacuation Center at Acadiana Fairgrounds which will be located on Highway 3212 on a 23 acre site adjacent to the Isle of Iberia. The Evacuation Center will be funded through ARPA funds and the State of Louisiana, with the project value being \$12,000,000 and the construction portion valued at \$10,875,000. The request for proposal of Iberia Parish Government requires that the project be placed for bid by May of 2024. The time line for completion of the project is Spring of 2026.
2. Mr. Mike Tarantino addressed the Iberia Parish Council to provide a quarterly update on Professional Economic Services provided by the Parish, all as authorized by Resolution No. 2021-27. Mr. Tarantino informed the Iberia Parish Council that the Iberia Parish monthly retail sales for the Month of October 2023 is \$135,816,000, lower than September 2023 which was \$149,900,000. Monthly unemployment rates for 2022-2023 is down significantly from this time last year. Job opportunities can be viewed on Iberia Industrial Development Foundation on Facebook and on louisianaworks.net. Mr. Tarantino gave monthly statistics for drilling permits, crude oil prices, rig count, natural gas price, Acadiana Regional Airport monthly operations and the new First Solar project.
3. Monthly Permit Report for the Month of October 2023 were emailed to Council Members.
