WHEREAS, on August 31, 2023, a crash occurred between an BNSF freight train and an 18-wheeler on the train tracks at the railroad crossing located on Airport Boulevard and Highway 182, in District 3: and

WHEREAS, access and travel in the area of Airport Boulevard train tracks where the train accident occurred has been restricted since August 31, 2023, causing hardships on Iberia Parish Government and local businesses and making other access points more dangerous; and

WHEREAS, the Iberia Parish Government and local businesses hereby urge the Department of Transportation and Development to reopen Airport Boulevard train tracks where the train accident occurred, to avoid restricting access to the Acadiana Regional Airport, located in District 3.
