The Parish Council of the Parish of Iberia, State of Louisiana, was duly convened as the Governing Authority of the Parish of Iberia by Mr. Warren P. Gachassin, Jr., its Chairman, who announced that the Council was now ready to conduct its business.

1. Councilman Eugene A. Olivier, Sr. thanked the General Public for their contributions to the Food Net Program.

PARISH PRESIDENT ANNOUNCEMENTS

- Parish President M. Larry Richard announced that the bid opening for the Courthouse Room Replacement Cooling Tower was awarded to Gallo Mechanical LLC., in the amount of \$514,000.
- 2. Parish President further announced that he attended a meeting with Paul Allain regarding the Evacuation Center on Wednesday, December 13, 2023. Others in attendance at the meeting were Civil Engineer, Construction Engineer, Mechanical Engineer, Electrical Engineer, CAO Milton "Beau" Belanger, Executive Secretary Cindy Provost, Director of Homeland Security Prescott Marshall, and Purchasing Office Michael Broussard. The next step of completion is to meet with Michael Prejean to discuss camera installations. Councilwoman Natalie Broussard has also been in attendance at the meetings as well. The Evacuation Center will be located next to the Isle of Iberia.
- 3. President Richard announced That the Public Works Department performed culvert cleaning in Districts 5,9, and 14 and culvert inspections in District 10 with culvert repairs being done in District 9. Tree removal and tree cutting was done in District 11 and road grating was done in Districts 3, 10, and 13.
- 4. President Richard informed the Council that illegal dumping in Districts 9, 10, 12, 13 is a big problem. He advised that Public Works is constantly dealing with this issue.
- 5. President Richard advised that road patching was conducted in Districts 2,3,5,9,10,13, and 14. He further advised that we will continue to patch until we have funds to overlay roads.
- 6. A Special Election will be held on April 27, 2024 for a dedicated 3/4% Road Tax. The goal is to develop an infrastructure that is needed to bring businesses to Iberia Parish and retain those businesses.
