COUNCIL MEMBER ANNOUNCEMENTS

1. Councilman Brock Pellerin yielded his time to New Iberia Spanish Festival Board Member Hannah Bertrand to address the Council regarding the Spanish Lake Festival to be held on April 11-13, 2025.
2. Councilman James P. Trahan announced that the Chili Cook-off will be held at the SugArena located at Acadiana Fairgrounds, 713 Northwest Bypass (Highway 3212), New Iberia, Louisiana on Saturday, March 29, 2025.
3. Councilman James P. Trahan also announced that Aline's Amazing Lemonade Stand Fund Raiser for benefit of Iberia Mental Health Initiative, will be held at 809 Briarwood Drive, New Iberia, Louisiana. The community is invited to attend.
4. Councilman Natalie Broussard announced that Iberia Mental Health Initiative will be hosting their annual Bayouside Run on Saturday, May 3, 2025 for mental health awareness.
5. Councilman Natalie Broussard also reminded everyone to go out and vote on Saturday, March 29, 2025 for Election Day.

PARISH PRESIDENT ANNOUNCEMENTS

1. President Richard informed the Iberia Parish Council that 6 people participated in the Litter Abatement Program on Saturday, March 15, 2025. A total of 82 bags of trash was collected in the areas of North Romero Road and U.S. 90 Under Pass.
2. President Richard informed the Iberia Parish Council that the Public Works Department completed several tasks during the period of March 12-25, 2025, including culvert cleaning and repairs, tree cutting and debris pickup, road patching and repairs, sidebooming of front ditches, as well as many other tasks.
3. President Richard informed the Iberia Parish Council that Homeland Security Director Brandon Miguez conducted a walk-thru of West Gate High School with Iberia Parish School Board Members in anticipation of using the facility as a designated evacuation pick-up point. This will replace the SugArena as an evacuation center to better accommodate Iberia Parish.
4. President Richard advised the Iberia Parish Council that the letting of Patoutville Overpass (DOTD) is expected to take place in the Summer of 2025. Construction will be reduce traffic to a single lane in each direction.
5. President Richard further advised the Iberia Parish Council that Homeland Security Director Brandon Miguez recommended that generators be installed at all recreation centers. These facilities often serve as critical hubs during emergency situations and distribution points for supplies.
6. President Richard informed the Iberia Parish Council that the generator for Iberia Parish Jail is ready for installation and Iberia Parish Government is currently waiting for the \$130,000 matching funds to be approved by the Iberia Parish Council to move forward with this project.
7. President Richard informed the Iberia Parish Council that an Emergency Operation Center Seminar is scheduled for June 18, 2025 and all Leadership and Emergency Support Function Leads are encouraged to attend the seminar which will include a simulation of a Category 2 Hurricane designed to test and improve all Emergency Preparedness Responses.
8. President Richard announced that Iberia Parish Government is currently seeking to hire several positions, including: 1)Wastewater Treatment & Collections Operator - Maintenance & Laborer; 2) Purchasing Agent; 3)Jeanerette Museum Attendant; 4) Building Inspector(Certified Residential and Commercial);

WHEREAS, there has been a request to amend the 2025 Royalty Fund Budget in the amount of \$3,750,000 to accept CPRA (GOMESA) funding from the State for St. Mary/Upland Levee (Delcambre/Avery and Commercial Canal Flood Control Structures and Pumps) engineering expenditures for said projects; and

WHEREAS, it is necessary to amend the 2025 Royalty Fund in the amount of \$3,750,000 to recognize said funding; and

WHEREAS, it is necessary to appropriate \$3,750,000 in additional funding for St. Mary/Upland Levee (Delcambre/Avery and Commercial Canal Flood Control Structures and Pumps) engineering expenditures for said projects; and

A RESOLUTION AUTHORIZING THE IBERIA PARISH PRESIDENT TO EXECUTE SUPPLEMENTAL AGREEMENT NO. 2 (TO A PREVIOUS AGREEMENT BY AND BETWEEN THE STATE OF LOUISIANA, DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT) WITH MEYER ENGINEERS, LTD. AND IBERIA PARISH GOVERNMENT RELATING TO STATE PROJECT H.013522.5, FEDERAL AID PROJECT NO. H013522, SOUTH LEWIS STREET WIDENING, IBERIA PARISH AND TO FURTHER AMEND THE 2025 ECONOMIC DEVELOPMENT DISTRICT NO. 1 FUND BUDGET IN THE AMOUNT OF \$57,499 TO RECOGNIZE FEDERAL FUNDING PASSED THROUGH LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR 80% OF TOTAL ENGINEERING SERVICES IN CONJUNCTION WITH SAID PROJECT.

WHEREAS, Resolution No. 2019-02, adopted January 9, 2019, authorizing the Iberia Parish President to execute an Agreement by and between the State of Louisiana, Louisiana Department Of Transportation and Development and Iberia Parish Government relating to State Project No. H.013522, Federal Aid Project No. H013522, South Lewis Street Widening, Iberia Parish; and

WHEREAS, it is necessary to authorize the Parish President to execute Supplemental Agreement No. 2 (to a previous agreement by and between the State of Louisiana, Department of Transportation and Development) with Meyer Engineers, Ltd., and Iberia Parish Government relating to State Project H.013522.5, Federal Aid Project No. H013522, South Lewis Street Widening, Iberia Parish; and

WHEREAS, the Iberia Parish Council does hereby authorize the Parish President to execute Supplemental Agreement No. 2 (to a previous agreement by and between the State of Louisiana, Department of Transportation and Development) with Meyer Engineers, Ltd. and Iberia Parish Government relating to State Project H.013522.5, Federal Aid Project No. H013522, South Lewis Street Widening, Iberia Parish; and

WHEREAS, the Louisiana Department of Transportation and Development has appropriated Federal funding in the amount of \$57,499 for the Lewis Street Widening Project, which will be utilized for the payment of 80% of the cost for engineering services; and

WHEREAS, is it is necessary to amend the 2025 Economic Development District No. 1 Fund Budget in the amount of \$57,499 to recognize federal funding passed through Louisiana Department of Transportation and Development for 80% of total engineering services in conjunction with Federal Aid Project No. H013522 - S. Lewis Street Widening Project Supplemental Agreement #2; and

WHEREAS, it is necessary to update the Funding Table to reflect the correct budgetary figures for this project.

NOW, THEREFORE, BE IT RESOLVED, that the Economic Development District No. 1 does hereby amend the 2025 Economic Development District No. 1 Fund Budget in the amount of \$57,499 to recognize Federal funding passed through State DOTD for 80% of total engineering services in conjunction with Federal Aid Project No. H013522 - S. A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT FOR THE MODIFICATION OF STATE HIGHWAY LA 3212 BETWEEN THE STATE OF LOUISIANA THROUGH THE DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT AND IBERIA PARISH; TO PROVIDE FOR THE EFFECTIVE DATE THEREOF; AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, the Iberia Parish Government and the Department of Transportation and Development agrees to enter into a Cooperative Endeavor Agreement for the modification of State Highway LA 3212 between the State of Louisiana through the Department of Transportation and Development and Iberia Parish; to provide for the effective date thereof; and to otherwise provide with respect thereto; and

WHEREAS, Article VII, Section 14 of the Louisiana Constitution provides that "for a public purpose, the State and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual"; and

WHEREAS, Louisiana State Route Highway LA 3212 is part of Louisiana State Highway System, which is under the authority and control of the DOTD; and

WHEREAS, the DOTD owns Louisiana State Route Highway LA 3212, located in Iberia Parish, Louisiana; and

WHEREAS, the Developer desires to finance and construct the Project described in Section 1.4 of the Agreement and agrees to construct the Project in accordance with the Plans and Specifications for the Project; and

WHEREAS, the DOTD desires to cooperate with the Developer by allowing the Developer to construct the Project in accordance with the terms and conditions provided in the Agreement; and

WHEREAS, upon completion of the Project, the Developer shall donate ownership of the Project and all necessary right-of-way to the DOTD; and

WHEREAS, the DOTD and the Developer have determined that the Project serves a public purpose because the DOTD's allowing the Developer to complete the Project will result in improved safety/improved efficiency/improved safety and efficiency to Louisiana State Route Highway and/or mitigate traffic issues and/or the effects the Developer's store or whatever will have upon the DOTD's roads, all at no cost to the DOTD; and

WHEREAS, the DOTD and the Developer hereby acknowledge that there is a reasonable expectation that the Project will result in economic benefit to the State and the DOTD that will exceed the value of the DOTD's obligations as set forth in the Agreement.

BE IT FURTHER RESOLVED, that the Iberia Parish President is also authorized to execute any and all other agreements, documents or other writings necessary to carry out the intent and purposes of this Resolution.

BE IT FINALLY RESOLVED, that this resolution shall become effective immediately upon adoption by the Iberia Parish Council and approval of the Parish President in accordance with Section 2-13 of the Iberia Parish Home Rule Charter.

RESOLUTION NO. 2025-58

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE AMENDMENT NO. 1 TO THE INTERGOVERNMENTAL AGREEMENT BETWEEN THE STATE OF LOUISIANA THROUGH THE COASTAL PROTECTION AND RESTORATION AUTHORITY AND IBERIA PARISH GOVERNMENT REGARDING CONSTRUCTION OF THE RODERE WATER CONTROL STRUCTURE PROJECT (TV-0087); TO PROVIDE FOR THE EFFECTIVE DATE THEREOF; AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, Iberia Parish Government has an opportunity to accept Amendment No. 1 to the Intergovernmental Agreement between the State of Louisiana through the Coastal Protection and Restoration Authority and Iberia Parish Government regarding construction of the Rodere Water Control Structure (TV-0087); to provide for the effective date thereof; and to otherwise provide with respect thereto; and

WHEREAS, Article VII, Section 14 of the Louisiana Constitution provides, in part, that "(f)or a public purpose, the state and its political subdivisions ... may engage in cooperative endeavors with each other..."; and

WHEREAS, pursuant to La. R.S. 49:214.5.2(A)(1), the Coastal Protection and Restoration Authority (the "BOARD") represents the State of Louisiana's position relative to the protection, conservation, enhancement, and restoration of the coastal area of the state through oversight of integrated coastal protection projects and programs and at La. R.S. 49:214.5.2.(A)(7), the BOARD has the power and authority to enter into any contract with any political subdivision of the study, planning, engineering, design, construction, operation, maintenance, repair, rehabilitation, or replacement of any integrated coastal protection project and to this end, may contract for the acceptance of any grant of money upon the terms and conditions, including any requirement of matching the grants in whole or part, which may be necessary; and

WHEREAS, pursuant to La. R.S. 49:214.6.1, the Coastal Protection and Restoration Authority ("CPRA") is the implementation and enforcement arm of the BOARD and is directed by the policy set by the BOARD, and pursuant to La. R.S. 49:214.6.2 and La. R.S. 49:214.6.3, CPRA shall administer the programs of the BOARD and shall implement projects relative to the protection, conservation, enhancement, and restoration of the coastal area of the State of Louisiana through oversight of integrated coastal projects consistent with the legislative intent as expresses in La. R.S. 49:214.1, and the BOARD directs, CPRA to administer and implement the obligations undertaken by the BOARD pursuant to this Agreement; and

WHEREAS, the IPG is the governing body of Iberia Parish, with the authority of a local political subdivision to enter into agreements with governmental bodies, such as the BOARD and/or CPRA, for the public welfare, health, safety, and good order of Iberia Parish by virtue of the specific authority granted in its Home Rule Charter and Article VII, Section 14 of the Louisiana Constitution; and

WHEREAS, the IPG is authorized under La. Const. Article VI, Part III of the Louisiana Constitution to provide for the construction and maintenance of levees, levee drainage, flood protection, and hurricane flood protection within the territorial jurisdiction of the IPG, and all purposes incidental thereto, including on its own behalf or for the areas or the levee districts under its authority; and

WHEREAS, under La. Const. Article VI, Part III, the construction, maintenance, and care and inspection of levees, and all other things incidental thereto, within the jurisdiction of the numerous levee districts and levee authorities established by Louisiana law shall devolve on the levee districts and levee

authorities and the boards of commissioners of the respective levee districts and levee authorities; and

WHEREAS, the Parties desire to enter into this Agreement for the purpose of lessening the threat of harm to citizens and damage to property in Iberia Parish through the reduction of flooding, by constructing the Rodere Canal Water Control Structure Project ("Project" or "Rodere Canal Water Control Structure Project"); and

WHEREAS, the Project is an integrated coastal protection project eligible for funding under Louisiana Constitution Article VII, Sections 9(B), 10.1 and 10.2, and La. R.S. 49:214.5.4(E) and

WHEREAS, the Project is consistent with the STATES'S 2017 Coastal Master Plan and Fiscal Year 2022 Annual Plan, and is identified as eligible for STATE funding, contingent upon funding being made available to the STATE for the Project; and

WHEREAS, during the construction phase, the STATE and IPG will mutually develop a specific operation, maintenance, repair, rehabilitation, and replacement (OMRR&R) plan for the Rodere Canal Water Control Structure; and

WHEREAS, this Agreement pertains to construction of the Rodere Canal Water Control Structure Project; and

WHEREAS, it is necessary to authorize the President of Iberia Parish to execute Amendment No. 1 to the Intergovernmental Agreement between the State of Louisiana, through the Coastal Protection and Restoration Authority (CPRA) and Iberia Parish Government regarding construction of the Rodere Water Control Structure (TV-0087).

NOW, THEREFORE, BE IT RESOLVED, that the Iberia Parish President is also authorized to execute Amendment No. 1 to the Intergovernmental Agreement between the State of Louisiana, through the Coastal Protection and Restoration Authority (CPRA) and Iberia Parish Government regarding construction of the Rodere Water Control Structure (TV-0087).
