2. Councilman Brock Pellerin thanked the Iberia Parish Public Works Department for responding quickly for the recent flood

event in his area.

3. Councilman Brock Pellerin announced that he attending the Chamber of Commerce Banquet and congratulated Acadiana Regional Airport for receiving the Business Impact Award for large businesses in Iberia Parish.

4. Councilman Marcus "Bruce" Broussard wished the Catholic High Baseball Team safe travels for the boys and their families as they participate in the 2025 Select Division III State

Championship.

- 5. Councilman Natalie Broussard announced that she and two members of CERT attended the Louisiana Emergency Management Conference hosted by Volunteer Louisiana in Lake Charles, Louisiana. They attended training sessions for Drinking Water and Emergency Response, Reunification Post Mass Casualty Incident, Medical Sheltering and Who's Eligible, How Does Triage Work, and Shelters vs. Extreme Weather Centers.
- 6. Councilman Scott Ransonet also thanked Iberia Parish Public Works Department for their assistance during the recent flood event.
- 7. Councilman Scott Ransonet also congratulated Catholic High School Baseball Team for their participation in the 2025 Select Division III State Championship.

### PARISH PRESIDENT ANNOUNCEMENTS

- 1. President Richard informed the Iberia Parish Council that there were 8 participants in the Litter Abatement Program on Saturday, April 26, 2025. A total of 122 bags of trash and other items were collected in the areas of N. Grand Prairie Road, S. Landry Drive, Neco Town Road (North and South) and Freyou Road.
- 2. President Richard informed the Iberia Parish Council that Household Waste Day was held on Saturday, May 3, 2025 with over 130 vehicles assisted with collection, recycling and proper disposal of 94 tires, 520 gallons of paint, 250 batteries, 200 of various cords and cables, various small appliances, electronics and mobile devices.
- 3. President Richard thanked the volunteers that worked for Household Waste Day, especially the Iberia Parish Sheriff's Department and Waste Connections for preparing meals for volunteers.
- 4. President Richard informed the Iberia Parish Council that the 2025 Hurricane Preparedness Meeting was on held by Homeland Security Director Brandon Migues on Tuesday, May 13, 2025 at the Sliman Theatre, New Iberia, Louisiana. Agencies from across the Parish attended to review evacuation procedures and response plans for the 2025 Hurricane Season. Key updates included rapid intensification, trends, pulse storm, damage assessment and the continued role of CERT.
- 5. President Richard also remind everyone to sign up for Iberia PINS by visiting the Iberia Parish Government website or SMART911.com to receive real-time alerts, notifications and important updates.
- 6. President Richard advised the Iberia Parish Council that he and Councilman Lady Fontenette Brown testified at the Louisiana State Capitol on Tuesday, May 13, 2025 in opposition

to House Bill No. 613 which creates an Iberia Parish Airport District. President Richard further stated that he is trying to make the people aware that the Iberia Parish Council adopted Resolution No. 2025-86 opposing House Bill 613 on April 23, 2025. He further stated that Iberia Parish has managed this asset for over 50 years and there is currently over \$1 Billion in construction taking place at the Acadiana Regional Airport and 1,000 jobs underway.

AN ORDINANCE AMENDING CHAPTER 20 OF THE COMPILED ORDINANCES TO ESTABLISH A SPEED LIMIT OF 35 MPH ON EARL B. WILSON ROAD, DISTRICT 10, AND AUTHORIZE THE PUBLIC WORKS DEPARTMENT TO INSTALL SPEED LIMIT SIGNS.

THAT THE IBERIA PARISH COUNCIL DOES HEREBY ORDAIN:

- SECTION 1. That Chapter 20, Section 20-108 Three- or four-way stop intersections of the Compiled Ordinances is hereby amended to include speed limit of 35 MPH on Earl B. Wilson Road, District 10, and authorize the Public Works Department to install speed limit signs, as follows:
  - (30) Speed limit of 35 MPH on Earl B. Wilson Road, District 10, and authorize the Public Works Department to install speed limit signs.
