COUNCIL MEMBER ANNOUNCEMENTS

1. Councilman Marcus "Bruce" Broussard congratulated the 2026 Senior Graduates of Iberia Parish and wished everyone the best of luck in their future endeavors.

PARISH PRESIDENT ANNOUNCEMENTS

1. Parish President M. Larry Richard announced that the Public Works Department completed numerous projects throughout Iberia Parish during the period of May 13, 2026 through May 27, 2026, including culvert repair, tree cutting, removal and debris pickup, road patching, shoulder work, sidebooming of front ditches, installation of debris buoy, removal of beaver dam, as well as many other tasks performed.
2. President Richard provided an update on Project A - Road Project and stated that all of the roads in this project are in various phases of construction. This project is expected to be completed ahead of schedule.
3. President Richard gave an update on Project B - Northside Road, continues to be milled and soil cement applied. Excessive rain caused the road to be closed last week due to poor driving conditions, however, the contractor was able to apply soil cement to stabilize the road allowing the road to re-open to traffic on Monday, May 25, 2026.
4. President Richard provided an update on Project C and stated that all roads are also in various phases of construction. Drainage work has been completed on Leonce Theriot, Kramer Drive, Charlotte Street and Chet Street. Utilities have been marked on Leon Landry. Roads have been completed on Oil Center, Agnes Broussard, and Julian Buteaux. Road patching will begin soon on Darnall Road at Admiral Doyle Drive.
5. President Richard stated that construction continues on the drainage portion of Hangar Drive Extension from Ed LaSalle to Ember. He further stated that Ed LaSalle Road is currently closed to traffic and will remain closed until June 25, 2026 to safely proceed with construction.
6. President Richard announced that bids were received for the Iberia Parish Jail Roof Project. The low bid came in under budget, allowing Iberia Parish Government to proceed within the next few weeks.
7. President Richard announced that he attended the Parish Presidents of Louisiana Meeting in Baton Rouge, Louisiana on Wednesday, May 27, 2026 in which they discussed Data Centers and PILOT Programs.
8. President Richard announced that he attended the Hazard Mitigation Plan Update Meeting on Tuesday, May 19, 2026. Also attending alongside President Richard were Emergency Management Officials and partners from across Iberia Parish and the State of Louisiana.

A RESOLUTION TO AUTHORIZE THE SELECTION OF COMMUNITY FIRST BANK AS FISCAL AGENT FOR IBERIA PARISH GOVERNMENT FOR AN INITIAL TERM COMMENCING JULY 1, 2026 AND ENDING DECEMBER 31, 2026, WITH OPTIONS TO RENEW.

WHEREAS, Iberia Parish Government requires the services of a qualified financial institution to serve as Fiscal Agent; and

WHEREAS, Community First Bank has been serving as Iberia Parish Government's Fiscal Agent and the current contract expires June 30, 2026; and

WHEREAS, the Iberia Parish Government desires to enter into a Fiscal Agent Services Agreement with Community First Bank for an initial term commencing July 1, 2026, and ending December 31, 2026, with the option to renew for up to four additional six-month terms;

NOW, THEREFORE, BE IT RESOLVED, that the Iberia Parish Council does hereby authorize the selection of Community First Bank as Fiscal Agent for Iberia Parish Government for an initial term commencing July 1, 2026 and ending December 31, 2026.

WHEREAS, at an election held in Sales Tax District No. 1 of the Parish of Iberia, State of Louisiana (the "**District**") on April 27, 2024, the District was authorized to levy and collect a three-fourths percent (3/4%) sales and use tax within its boundaries as they existed on such date (the "**Tax**"); and

WHEREAS, the District has previously issued its \$17,000,000 Sales Tax Revenue Bonds, Series 2024 (the "**Series 2024 Bonds**"), which are secured by and payable from an irrevocable pledge and dedication of the revenues to be derived by the District from the proceeds of the Tax, subject only to the payment of the reasonable and necessary costs and expenses of collecting and administering the Tax (the "**Net Revenues of the Tax**"); and

WHEREAS, the Iberia Parish Council desires to undertake additional projects in the District and therefore desires to authorize the issuance of not to exceed Thirty Million Dollars (\$30,000,000) of Sales Tax Revenue and Refunding Bonds of the District (the "**Bonds**"), in the manner authorized and provided by Part II of Chapter 4 of Subtitle II of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority (the "**Act**"), for the purpose of (i) constructing and improving roads and streets within the District, (ii) refunding all or a portion of the Series 2024 Bonds, and (iii) paying the costs of issuance of the Bonds; and

WHEREAS, the Bonds shall be secured by and payable from the Net Revenues of the Tax; and

SECTION 2. **State Bond Commission.** Application is hereby made to the State Bond Commission, Baton Rouge, Louisiana, for approval of the issuance and sale of the Bonds and for consent and authority to proceed with the issuance and sale of the Bonds as provided above, and Bond Counsel is directed to make application to the State Bond Commission in accordance with the foregoing on behalf of the District. 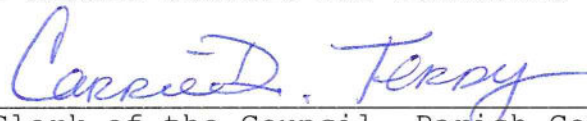
