ITEM #1 – DISCUSS AND VOTE ON A RESOLUTION TO REVISE THE BUDGET FOR CONTRACT NO. 1 AND CONTRACT NO. 3 OF THE WATER SECTOR PROJECTS. (BRAD CRADEUR)

Brad Cradeur addressed the board regarding Water Sector Projects Contract No 1 and Contract No. 3 and reviewed with the board "WATERWORKS DISTRICT NO. 3 (COTEAU) WATER SECTOR PROGRAM PROJECT BUDGET, REVISED FEBRUARY 22, 2024" AND "BID TABULATION, WATER SYSTEM IMPROVEMENTS, CONTRACT NO. 1, WATER WELL NO. 5, WATERWORKS DISTRICT NO. 3 (COTEAU)/IBERIA PARISH".

Pam Granger advised that she attended a Water Sector Meeting today and explained the present issue with pricing at this time.

Brad Cradeur continued his presentation and presented a new plan to move funds from Contract #3 to Contract #1 and work on Contract #2.

Paul Trahan suggested to adopt a Resolution to move \$600,000 from Contract #3 to Contract #1. Discussion was had regarding the bids.

It was motioned by Ray Gary and seconded by Barrett Hebert to adopt a Resolution to revise the Budget for Contract #1 and Contract #3 of the Water Sector Projects by moving \$600,000 in Construction Proceeds and any associated engineering fees from Contract #3 to Contract #1 to begin progress. Motion carried by unanimous vote.

shall be revised by moving \$600,000 and any associated Engineering fees in Construction proceeds from

Contract #3 to Contract #1 to begin progress

He recommended that all bids be rejected and re-bid the project.

Discussion was had regarding the re-bid process.

It was motioned by Barrett Hebert and seconded by Ray Gary to adopt a resolution to reject the bids for Contract No. 2 of the Water Sector Projects due to a potential unresponsive bid submittal and re-bid the project in accordance with State Bid Law and Guidelines. Motion carried by unanimous vote.

Timothy Henry gave the Statewide Electrical Services Report by reviewing "Waterworks District No. 3 Operation & Maintenance, January – February 2024".

Brad Cradeur advised the board that Timothy Henry is the Designated Operator and is at the plant permanently, Monday through Friday, and is working quite well.

Brad Cradeur informed the board of a news reporter who was on the Waterworks #3 Facebook Page and wanting to interview Waterworks District #3 customers.

Brad Cradeur advised the board that operations are monitored daily and back-up parts are in stock and readily available; there is a protocol in place for when we find problems.

Discussion was had regarding a customer complaint of yellow water.

REPORT FROM BRENDA ROMERO

Brenda Romero gave her report and advised the board that Philip Flugence and Fredrick Phillips flushed all lines around where the complaints were reported. She stated that Gwen Romero is working out really well.
