LEMAIRE MEMORIAL AIRPORT- Mayor Bourgeois came by to say hello and thanked the commissioners for all they do for the airport.

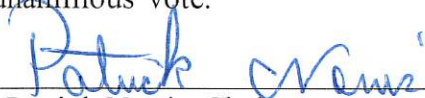

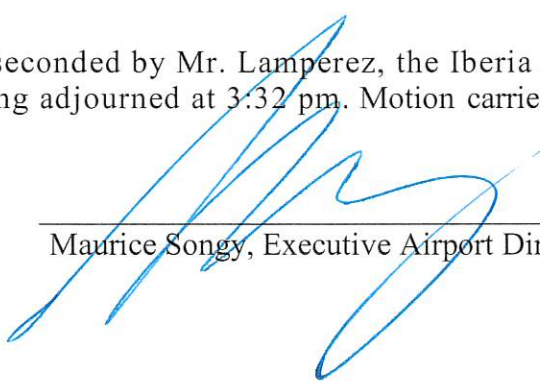
