LEVYING OF MILLAGES FOR THE YEAR 2025 FOR IMMEDIATE RELEASE

NEW IBERIA, LA - JUNE 7, 2025 - The Iberia Parish Council will hold a public hearing and a public meeting on July 23, 2025 to hear public comments and adopt Ordinances to levy the millage rates for the year 2025.

Persons wishing to address the Council during the public hearing should complete a Speaker Participation Form and turn into the Clerk prior to the beginning of the meeting on July 23, 2025. Forms will be available at the meeting.

Publications will appear in the official journal, The Daily Iberian, as follows:

Notice is hereby given pursuant to Article 7, Section 23(C) of the Louisiana Constitution and R.S. 47:1705 (B) that a public hearing of the Iberia Parish Council in Iberia Parish will be held at its regular meeting place in the Council Chambers located on the 4th Floor of the Main Court Building, located at 300 Iberia Street, New Iberia, LA on Wednesday, July 23, 2025 at 6:00 p.m. and that Iberia Parish Government intends to consider levying additional or increased millage rates without further voter approval or adopting the adjusted millage rates after reassessment and rolling forward to rates not to exceed the prior year's maximum. The estimated amount of tax revenues to be collected in the next year from the increased millage, General Alimony, is \$1,702,086.72 and the amount of increase in taxes attributable to the millage increase is \$25,658.68. The estimated amount of tax revenues to be collected in the next year from the increased millage, Exempted Municipalities, is \$392,276.19 and the amount of increase in taxes attributable to the millage increase is \$15,521.17. The estimated amount of tax revenues to be collected in the next year from the increased millage, Public Buildings, is \$2,872,913.14 and the amount of increase in taxes attributable to the millage increase is \$65,508.94. The estimated amount of tax revenues to be collected in the next year from the increased millage, Health Unit, is \$1,273,497.21 and the amount of increase in taxes attributable to the millage increase is \$29,038.63. The estimated amount of tax revenues to be collected in the next year from the increased millage, Drainage Facilities, is \$2,414,212.72 and the amount of increase in taxes attributable to the millage increase is \$55,049.53.
